I likewise release from liability any person transporting my child to or from activities of the organization.

I understand that I will be charged a one-time \$50 refundable volunteer fee for the 2010 season. This fee will be refunded to me after I have worked the field day selected below. If I do not participate on that date, I will forfeit my volunteer fee and PBO, Inc. shall use these funds as they deem necessary to run the league.

I also understand that for each child playing, I agree to work one shift in the concession stand during the 2010 season. PBO, Inc. reserves the right to cancel the registration of any player participating in any sport which interferes or conflicts with regular season baseball games. PBO reserves the right to suspend or expel any registered PBO player, coach or manager for conduct detrimental to the league pursuant to the provisions of the PBO rules and regulations.
